

Minutes of the Village of Holland Council Meeting
Held Tuesday, January 18, 2022

At 7:34 pm Acting Mayor Ryan Spangler called the meeting to order. Councilmembers Mike Bettinger, Roger Burditt, Nathan Gaubert, Clerk-Treasurer Lyn Krasula and Village Attorney Paul Skaff were present. Mayor Lee Irons, Scott Brown and Terry Nachtrab were absent.

Village Attorney Skaff administered the Oath of Office for new councilman Nathan Gaubert.

Mr. Burditt made a motion to approve the minutes from the 1/4/22 council meeting as presented by the Clerk-Treasurer. Mr. Bettinger seconded the motion with roll call carrying four ayes.

Mr. Spangler reviewed a contract for Noris that is used by the police department to run criminal history checks for 2022. This contract was signed by police chief Bob Reed without bringing it before council for PO approval. The cost of the 2022 contract was \$11,800. This issued now needs council’s approval for a PO as one was not properly obtained at the time it was signed. Mr. Burditt made a motion to authorize the clerk to issue a PO for the Noris contract. Mr. Bettinger seconded the motion with roll call carrying four ayes.

After review, Mr. Bettinger made a motion to approve payment of bills totaling \$681,447.65 as distributed by the Clerk-Treasurer. Mr. Gaubert seconded the motion with roll call carrying four ayes.
