

VILLAGE OF HOLLAND, LUCAS COUNTY, OHIO  
ORDINANCE NO. 11-2022

AN ORDINANCE RESCINDING HOLLAND CODIFIED ORDINANCE CHAPTER 112, ORDINANCE 19-2010, ORDINANCE 7-2004 AND ADOPTING THE LUCAS COUNTY, OHIO ILLICIT DISCHARGE ELIMINATION REGULATIONS, SOIL EROSION AND SEDIMENTATION REGULATIONS, STORMWATER MANAGEMENT PLAN AND AUTHORIZING THE MAYOR TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH THE LUCAS COUNTY ENGINEER AND TO SIGN SAID MEMORANDUM OF UNDERSTANDING

WHEREAS, the Village of Holland is a co-permittee of the Lucas County, Ohio NPDES MS4 permit: and

WHEREAS the Village of Holland recognizes the feasibility of a working relationship with the Lucas County, Ohio in meeting the requirements of the NPDES MS4 permit including adopting illicit discharge elimination rules, soil erosion and sedimentation rules, and stormwater management plan; and

WHEREAS the memorandum of understanding with the Lucas County Engineer, Ohio will provide assistance in enforcing illicit discharge elimination rules, soil erosion and sedimentation and stormwater management minimum control measures; and

WHEREAS, adopting the Lucas County, Ohio regulations for illicit discharge elimination, soil erosion and sedimentation and stormwater management provides consistent regulations throughout the County.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF HOLLAND, OHIO THAT:

SECTION 1. Chapter 112 of the Holland Codified Ordinances (Ordinance 19-2010) is hereby rescinded in its entirety and the most current Lucas County Illicit Discharge Elimination Rules, and any revisions or updates made to such rules in the future are hereby adopted as shown in exhibit A attached.

SECTION 2. Ordinance 7-2004 is hereby rescinded in its entirety and the most current Lucas County Soil Erosion and Sedimentation Rules are hereby adopted as shown in exhibit B attached.

SECTION 3. The Village of Holland adopts the most current Lucas County Stormwater Management Plan, and any revisions or updates made to such plan in the future as shown in exhibit C attached.

SECTION 4. The mayor is hereby authorized to enter in to and sign a Memorandum of Understanding with the Lucas County, Ohio Engineer for assistance in assuring the Village of Holland is compliant with the Lucas County NPDES permit of which the Village is a co-permittee as shown in exhibit D attached.

It is hereby found and determined that all formal actions of the council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meeting s open to the public, in compliance with all legal requirements of the Village of Holland and the State of Ohio.
