Rail Park Field will be available for team practices seven days a week at designated times. All use of the field will be by application only. THE FIELD WILL BE OPEN AFTER APRIL 1, 2025, AT THE DISCRETION OF THE MAINTENANCE DEPARTMENT. WEATHER AND GROUND CONDITIONS WILL DETERMINE THE OFFICIAL FIELD OPEN DATE.

SPRING: Applications will be accepted beginning March 3, 2025, and must be received by March 17, 2025. Approved applicants will be notified by March 24, 2025. Permits will be valid from April 1 through August 1, 2025. APPLICATIONS RECEIVED PRIOR TO MARCH 3, 2025, AND AFTER MARCH 17, 2025, WILL NOT BE CONSIDERED.

FALL: Applications for fall practice will be accepted beginning July 7, 2025, and must be received by July 21, 2025. Approved applicants will be notified by July 28, 2025. APPLICATIONS RECEIVED PRIOR TO JULY 7, 2025, AND AFTER JULY 21, 2025 WILL NOT BE CONSIDERED. Permits will be valid from August 4, 2025, to November 1, 2025.

Only one team will be scheduled per time slot. Teams will be allowed no more than two time slots per week. Upon review, if more than one team has applied for the same day and time slot, the earliest received application will be approved. **Priority will be given to Village residents regardless of the time the application was received. New applications must be submitted each season.**

Successful applicants will be required to police area for trash and to adhere to the following rules: no climbing on fences or backstop; no trespassing on neighboring properties, no soft toss hitting into any fencing, no damaging or altering any of the facility; no vehicles on grass area. Report any abuse or misuse of the area to the Village office or Police Department.

Field reservations will be scheduled for Monday through Friday from 4pm to 8pm and Saturday and Sunday from 9am to 5pm.
