Mayor Irons opened the zoning public hearing at 7:45pm with Mr. Duane Dodson, 7109 Railroad St in attendance. Discussion was held on a request by Planning Commission to change the zoning of 7103 Railroad and 7109 Railroad from R1 Single Family Dwelling o R3 Multi-Family Dwelling. The request is made based on the proposed renovation of 7103 Railroad St to a multi-family structure and to amend the legal nonconforming status of 7109 Railroad which is currently zoned R1 and is used as a multi-family structure. Mr. Spangler made motion to accept the recommendation of Planning Commission and approve the zoning change from R1 to R3 for 7103 and 71096 Railroad St. Mr. Gaubert second with roll call carrying six ayes.

Discussion was held on the proposed renovations and construction of an accessory structure with living quarters at 7103 Railroad St. The renovations to the existing structure will require a variance on side yard setback. The accessory structure will also require side yard setbacks. Mr. Spangler made motion to reduce the required ten foot side yard setback by five feet on the west side of the existing structure and to reduce the east, west and south side yard setback of the proposed accessory structure by five feet. Mr. Gaubert second with roll call carrying six ayes.

Council returned to regular session at 7:46pm.
