FIRST AMENDED AGREEMENT

FOR RESIDENTIAL SOLID WASTE AND RECYCLING COLLECTION SERVICES WITHIN THE

VILLAGE OF HOLLAND'S TERRITORIAL JURISDICTION AS PROVIDED BY REPUBLIC SERVICES

THROUGH A SUCCESSOR AGREEMENT BETWEEN THE VILLAGE OF HOLLAND AND

THE LUCAS COUNTY SOLID WASTE MANAGEMENT DISTRICT

WHEREAS, on March 26, 2019, the Board adopted Resolution 19-308, authorizing to Assign the Service Provider Agreement for Solid Waste and Recycling Collection Services with Stevens Disposal and Recycling Service, Inc. to Republic Services from April 1, 2019 through August 31, 2023 for the Village of Holland (Consent for Assignment Agreement - attached hereto and incorporated fully herein as Exhibit "A"); and

WHEREAS, by agreement effective September 1, 2018, by and among the Board of Commissioners of Lucas County, Ohio, (the "Board"), by and on behalf of the Lucas County Solid Waste Management District (the "District"), established and maintained under the laws of the State of Ohio, with offices located at 1011 Matzinger Rd, Toledo, Ohio, 43612, and the Village of Holland, (the "Village"), an Ohio municipal corporation organized and existing under the Constitution and laws of the State of Ohio, with its principal place of business located at 1245 Clarion Ave., Holland, OH 43528 (Solid Waste and Recycling Collection Service Agreement - attached hereto and incorporated fully herein as Exhibit "B"); and

WHEREAS, by agreement effective September 1, 2018, by and among the Board of Commissioners of Lucas County, Ohio, (the "Board"), by and on behalf of the Lucas County Solid Waste Management District (the "District"), established and maintained under the laws of the State of Ohio, with offices located at 1011 Matzinger Road, Toledo, Ohio 43612, and Stevens Disposal and Recycling Services, Inc. ("STEVENS"), a corporation with its principle place of business located at 16929 Ida West Road, Petersburg, MI 49270 (Service Provider Agreement - attached hereto and incorporated fully herein as Exhibit "C"); and

FIRST AMENDED AGREEMENT

WHEREAS, on July 31, 2018, the Board adopted Resolutions 18-642 and 18-643, authorizing the District to enter into agreements with the Village of Holland and Stevens Disposal and Recycling Services, Inc. to provide residential solid waste and recycling collection within the Village's territorial jurisdiction as provided by the Service Provider; and

WHEREAS, on July 31, 2018, the Village of Holland passed Ordinance No. 19-2018, authorizing the Mayor to enter into a successor agreement with the District to provide for residential solid waste and recycling collection within the Village's territorial jurisdiction; and the expenditure to pay for said services; and

WHEREAS, the term of the Agreements attached hereto as Exhibits "A", "B" and "C" is scheduled to expire on August 31, 2023, with 1-five year option to renew with the parties reserving the right to renew or renegotiate;

NOW, THEREFORE, the parties hereto mutually agree to amend the term of the Agreements:

1. **EFFECTIVE DATE:**

This First Amended Agreement shall be effective on September 1, 2023, and shall remain effective until August 31, 2028 as the five year option to renew.

2. **FEES & FEE ADJUSMENTS:**

The Village shall pay a monthly per household fee of \$12.39 per month (\$7.32 refuse and \$5.07 recyclables) per household effective September 1, 2023 with annual adjustments to the household fee beginning September 1, 2024 and each September thereafter at 4.5% per year (\$12.95, \$13.53, \$14.14, \$14.78).

3. **REMAINING PROVISIONS:**

Except as expressly modified herein, all other provisions of the Agreements attached hereto and fully incorporated herein as Exhibits "A", "B" and "C" to shall remain in full force and effect.
