

ORDINANCE NO. 12-2023
VILLAGE OF HOLLAND, LUCAS COUNTY, OHIO

Ordinance Approving a Contract for the Collection of Solid Waste and Recycling Services, and Authorizing the Mayor to Sign the Contract, and Declaring an Emergency

WHEREAS, the Village of Holland is a statutory village located in Lucas County, Ohio, and

WHEREAS, the Village of Holland has powers of local self-government pursuant to Ohio Constitution Article XVIII, Section 3, and

WHEREAS, the Village entered into a contract for the collection and recycling of solid waste in the Village which is set to expire August 31, 2023. Such services are currently provided by Republic Services, and

WHEREAS, the Village of Holland considered options for the collection and recycling of solid waste for the Village and its residents, and after deliberations determined it in the best interest of the Village and its residents to renew the agreement for such services after August 31, 2023, and passed Ordinance 2-2023 approving a renewed contract, and

WHEREAS, Republic Services, the firm with which the Village agreed to renew its agreement for the collection and recycling of solid waste, declined to accept the renewal terms, leaving the Village without a waste collection contractor after August, 2023, and

WHEREAS, on behalf of the Village, Lucas County submitted a bid request for solid waste collection and recycling services in the Village and determined Republic Services' bid to be the lowest and best, and

WHEREAS, the Village Council has reviewed the bid proposal and corresponding agreement proposal and has agreed to renew its contract with Republic Services under the terms set forth in its proposal.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF HOLLAND, LUCAS COUNTY, OHIO, THAT:

1. Ordinance 2-2023, approving a contract to renew the Village's contract for solid waste and recycling services with Republic Services under the terms then proposed, is hereby repealed.
2. The Mayor is hereby authorized to enter into a contract, on behalf of the Village of Holland, for collection of solid waste and recycling services within the Village of Holland, in substantially the same form as the attached exhibit, and that such contract is hereby approved.
3. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any other committees that results in such formal action were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

This measure is an emergency measure necessary to the health and safety of the Village and its residents for the reason that the Village's current contract for solid waste collection and recycling services is set to expire in August, 2023, and there are an insufficient number of regularly scheduled meetings before the contract's expiration necessary to give this matter three readings. Further, the collection of the Village's solid waste and recycling is essential to the health and safety of the community.
