AN ORDINANCE AMENDING SECTION 105.01 AND 105.03 OF THE VILLAGE OF HOLLAND
CODIFIED ORDINANCES.

WHEREAS, the Council of the Village of Holland, Ohio finds that changes need to be made in Section 105.01 and 105.03 of the Codified Ordinances of the Village of Holland, Ohio,

SECTION 1. Section 105.01 of the Codified Ordinances of the Village of Holland is hereby amended by interlineation and shall read as follows.

SECTION 2. Section 105.03(a) of the Codified Ordinances of the Village of Holland is hereby amended to read as follows. All other portions of 105.03 remain unchanged.

105.03 UNIFORM ALLOWANCE FOR POLICE.

- (a) The Police Chief, and all full-time officers of the Police Department, after one year of service, shall be provided with a uniform allowance of Five Hundred (\$800.00) Dollars per year (increase effective 1/1/2024 and based on a full year of service). Uniform allowance will be reimbursed to the employee with proof of purchase and authorization of the Chief of Police.

SECTION 3. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
