

VILLAGE OF HOLLAND, LUCAS COUNTY, OHIO
RESOLUTION NO. 50 - 2024

A RESOLUTION APPROVING AND ENDORSING THE LUCAS COUNTY ACTIVE TRANSPORTATION
PLAN AND ITS OBJECTIVES.

WHEREAS, the Village of Holland is an Ohio Charter municipality with powers of local self-government pursuant to Ohio Constitution Article XVIII, Sections 3 and 7, and

WHEREAS, the Toledo/Lucas County Health Department and Live Well Greater Toledo helped develop a transportation plan, known as the Lucas County Active Transportation Plan, (the Plan), and

WHEREAS, “Active Transportation” is an umbrella term for all the ways people can get around without using a motorized vehicle – human powered travel such as walking, cycling, using mobility assistance devices such as wheelchairs and scooters, skating or skateboarding, and more, serving many goals, including, but not limited to, improving physical and emotional health and the environment, and

WHEREAS, the Plan proposes many miles of active transportation networks throughout greater Toledo and Lucas County, and

WHEREAS, endorsement of the Plan may assist in supporting future funding applications and opportunities for the Village of Holland to develop components of the Plan, which, it is hoped, will provide myriad benefits to the community, and

WHEREAS, the Lucas County Commissioners and several cities, villages and townships in Lucas County have approved and endorsed the Plan, and

WHEREAS, the council of the Village of Holland believes that endorsement of the Plan will benefit the Village and its residents.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE OF HOLLAND, OHIO,

Section 1. That the Council of the Village of Holland hereby approves and endorses the Lucas County Active Transportation Plan and its objectives. A summary of the Plan is attached hereto. A copy of the Plan can be found at <https://www.livewelltoledo.org/local-active-transportation>.
