Minutes of the Village of Holland Council Meeting Held Tuesday, April 15, 2025

At 6 pm Mayor Ryan Spangler called the meeting to order. Council members Justin Hoen, Sandy Almond, Mike Bettinger, President Scott Brown, Sandra Hensley, Nathan Gaubert, Village Attorney Paul Skaff, Clerk-Treasurer Lyn Krasula and Administrator Bob Bethel were all in attendance. Mr. Bettinger made a motion to approve the minutes of the 4/1/25 council meeting as corrected. Ms. Hensley seconded the motion with roll call carrying four ayes. Mr. Brown and Mrs. Almond abstained.

Mayor Spanger reviewed a Lexipol subscription renewal which is for the police department policy and procedure program. Mr. Brown made a motion to approve the Lexipol renewal at an annual cost of \$7,332.33. Mr. Gaubert seconded the motion with roll call carrying six ayes.

Mayor Spangler discussed the need to set council summer session dates and recommended meetings be held on June 17, July 15 and August 19 for 2025. Mr. Gaubert and Attorney Skaff would be unavailable for the 6/17/25 meeting. Mr. Brown made a motion to approve the 2025 summer session dates as recommended by the Mayor. Mr. Hoen seconded the motion with roll call carrying six ayes.

Mr. Brown made a motion to suspend regular rules of council to allow Ordinances 14 & 15-2025 to be read by title only. Ms. Hensley seconded the motion with roll call carrying six ayes.

First reading of Ordinance No. 14-2025, ORDINANCE AUTHORIZING PARTICIPATION IN THE ODOT ROAD SALT CONTRACTS AWARDED IN 2025, was read by title only. Mr. Brown made a motion to suspend regular rules of council to dispense with the second and third readings. Ms. Hensley seconded the motion with roll call carrying six ayes. Mr. Brown made a motion to approve the first and final reading. Mrs. Almond seconded the motion with roll call carrying six ayes.

First reading of Ordinance No. 15-2025, AN ORDINANCE PROVIDING FOR THE RE-ENACTMENT OF CERTAIN SECTIONS OF ORDINANCE NO. 11-2025, was read by title only. Mr. Brown made a motion to suspend regular rules of council to dispense with the second and third readings. Mrs. Almond seconded the motion with roll call carrying six ayes. Mr. Gaubert made a motion to approve the first and final reading. Mrs. Almond seconded the motion with roll call carrying six ayes.

Chief Piotrowski stated the police will be participating in a drug buy-back event to be held on April 26 from 10 am to 2 pm. Drop off locations will be at both the police station and Kroger parking lots.

Mr. Bethel detailed highlights from his Administrator's report including landscaping proposals for the municipal grounds and the Whisperwood tree removal project.

Mr. Bettinger made a motion to authorize payment of bills totaling \$500,954.72 as presented by the Clerk-Treasurer. Mrs. Almond seconded the motion with roll call carrying six ayes.
