

VILLAGE OF HOLLAND, LUCAS COUNTY, OHIO  
ORDINANCE NO. 18 - 2025

AN ORDINANCE APPROVING A CONTRACT SERVICES AGREEMENT, AND A MANAGEMENT AND COST SHARING AGREEMENT WITH SPRINGFIELD TOWNSHIP, AND DECLARING AN EMERGENCY

WHEREAS, the Village of Holland is an Ohio Charter municipality in Lucas County with powers of local self-government pursuant to Ohio Constitution Article XVIII, Section 3, and

WHEREAS, Springfield Township is an Ohio Township located in Lucas County, Ohio, and

WHEREAS, the Holland Springfield Spencer Historical Society (Society) is an Ohio non-for-profit corporation formed in 1997 “to preserve, record and collect the historical data, legacy, statistics and memoirs of the area of Lucas County, Ohio encompassing the Village of Holland, and the Townships of Springfield and Spencer”, and

WHEREAS, the Village of Holland and Springfield Township desire to ensure the continued purposes of the Society, and the Village desires to retain the services of an individual to provide event planning, coordination, media relations, fundraising, and management services to the Village for the benefit of the Society and consistent with the purposes of the Society, and

WHEREAS, Springfield Township desires to contribute to the costs of such services.

NOW, THEREFORE, BE IT ORDAINED, BY THE VILLAGE OF HOLLAND, OHIO, THAT:

SECTION 1. The Council of the Village of Holland hereby approves a Contract Services Agreement in a form substantially similar to the attached, and hereby authorizes the Village Administrator to execute said agreement.

SECTION 2. The Council of the Village of Holland hereby approves a Management and Cost Sharing Agreement between the Village of Holland and Springfield Township, in a form substantially similar to the attached, and hereby authorizes the Village Administrator to execute said agreement.

SECTION 3. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this council, and that all deliberations of this Council and any of its Committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4. This measure is an emergency measure, necessary to the immediate preservation of the health and safety of the Village and its residents, for the reason that contract services for the referenced services to the Society has been reached and to preserve continuous and seamless service and funding for said services is important to the Village and the Township and the community.
